Barb Hilty – Financial Analyst

- General Fund Goal: \$57,540, General Fund YTD: \$32,845.54, General Fund Due: \$24,694.46
- Student Income Goal: \$35,703.75, Student Income YTD \$31,599.42, Student Income Outstanding \$4,104.33. 93 students are paid in full.
- New 2010/2011 Marching Band Season Budget was introduced to the membership. Proposed budget total is \$87,365.
- Student Assessment for 2010/2011 Marching Band Season is \$395. In previous years, the assessment has been as much as \$550. Because our KAIB fundraising was down by nearly 40%, this past season, the budget goal was short by \$24,694.46 for the year.
